**Understanding the NRCS High Tunnel Program**

The USDA's National Resource Conservation Service offers financial assistance to agricultural producers who want to use high tunnels to grow fruits and vegetables. This program encourages growers to produce sustainable agricultural products and provide citizens with quality, locally grown food. In order to receive funding the land must already be in production and producers must meet eligibility requirements for the Environmental Quality Incentives Program (EQIP) prior to installation. Both established farmers and beginning producers can apply. The purpose of the high tunnel must be to extend the growing season and improve production. NRCS may also provide funding for supporting activities such as irrigation, pest control, crop rotation and more.

Rimol High Tunnels are approved by the NRCS as qualifying EQIP structures. If you are interested in participating in this program, please contact Kenai Feed so we can guide you through the process of purchasing and installing a high tunnel.
